General Provisions

- These specific terms and conditions are from THE BELGIAN HEMATOLOGY SOCIETY (BHS) (Chaussée de Louvain, 479 in 1300 Brussels, Belgium), with VAT BE0434.918.405.
- When registering to BHS website, the subscriber agrees with these Terms & Conditions.
- If one or more provisions of these Terms & Conditions is invalid or nullified the remaining provisions shall continue to apply in full. In that case BHS and the subscriber shall consult and agree new provisions to replace the provision(s) that are invalid or nullified, wherever possible taking due account of the object and scope of the invalid or nullified provisions.
- These Terms & Conditions are governed by Belgian law. Disputes concerning these Terms & Conditions shall be heard exclusively by the competent court of BRUSSELS.

Subscription to the BHS website

- The subscription includes access to password protected webpages of the website: <https://bhs.be>.
- The subscription is valid for 12 months from January 1st to December 31st which corresponds to the deadlines of BHS membership. Renewal of the subscription is possible via your online member profile.
- At regular time intervals, BHS will announce which digital e-learning material/content will be published on these password protected webpages. This could be: webinars, lecture recordings, courses, etc.
- To access live webinars, an additional registration will be necessary for RIZIV (Rijksinstituut voor ziekte- en invaliditeitsverzekering)/INAMI (Institut national d'assurance maladie-invalidité) accreditation purposes.
- A subscription is strictly individual and personal and cannot be transferred to another person. Sharing your log-in details is therefore not allowed.

Cancellation policy

- Cancellation of the subscription has to be made in writing to the Secretariat via bhs@seauton-international.com upon which the Secretariat will remove your entry from the subscribers database, or unsubscribing via the newsletter.

Permission to contact

- The subscriber agrees that his/her (online) presence will be monitored and registered, including name, institutions and e-mail address.

- If the course is accredited, the criteria to receive a certificate of participation, allowing to claim the points, will be announced on the website (e.g. : monitoring of watching behaviour, successful completion of an accreditation assessment, ...).
- Subscribers agree that it's the exclusive right of the Secretariat to establish the criteria and to monitor whether or not subscribers fulfil the criteria to be issued a certificate. Appeal to the decision of the Secretariat have to be submitted in writing to the Secretariat and will be treated by the Scientific Committee of BHS.
